To avoid data loss, do **NOT** use the symbols < or > when entering information into the Researcher Portal. These symbols are unsupported.



Using these symbols can cause issues such as **loss of work** and/or **error messages**.

Note that saving errors may occur, even if you do not receive an error message.

Receiving a Review Assignment



• When you are assigned as a reviewer to a file, you will receive an email notification that there is a new application or event form for you to review on the Memorial Researcher Portal.

To view the application or event form, follow the Login instructions in the Basic User Manual to login to the Memorial Researcher Portal. The Basic User Manual can be found on <u>https://rpresources.mun.ca/wp-</u> <u>content/uploads/2016/10/17.10.2016-Navigation-Manual.pdf</u>



When you log into the Memorial Researcher Portal, you will see the Home Page. The **Reviewer Role Block** on the Home Page, provides links that will direct you to applications or event forms where you have been assigned as a reviewer. You can review and submit feedback for applications and event forms by selecting one of the links.

Applications: Chair or **Events: Chair**: These links will contain applications or event forms where you are assigned as the Chair for the review. The Chair can save comments throughout the review that are viewable to all reviewers assigned to the same file.

Once the review is completed by all reviewers, the Chair will make an approval decision. When the approval decision is made, the file will disappear from the menu and is no longer accessible. It is important as the Chair, that you ensure all reviewers are finished with their reviews prior to making a decision.



Applications: Reviewer or **Events: Reviewer**: These links will contain applications or event forms where you are assigned to complete a review. You can save comments throughout the review that are viewable to all reviewers assigned to the file.

When you initially receive a file for review, it will appear under the link suffixed with "New". Once you save comments it will then move to the link suffixed with "In Progress". Once the Chair makes an approval decision on a file, it will disappear from your links.



All of your review assignments will initially appear as a new application or new event form in the **Reviewer Role Block**. Click on the appropriate link to access all new review assignments requiring your review.

There are two methods available to you as a reviewer to view an application:

- You can review the application in the Researcher Portal by navigating through the tabs. Please see slide 15, <u>Adding and</u> <u>Submitting Reviewer Comments</u>, for more information on this method.
- You can also review the application by using the Export to Word or Export to PDF*Application Action buttons. A further explanation of this method of review is described in slide 16, <u>Adding and</u> <u>Submitting Reviewer Comments</u>.



You can review the application by navigating through the various tabs highlighted below. The tabs include Project Info, Project Team Info, Application Custom Questions, Attachments, Approvals and Logs. **The information in the Committee Reviews tab is** <u>only</u> **visible to reviewers and ethics office administrators.**

- **Project Info**: Includes basic information about the application (Project Title & Dates).
- Project Team Tab: Includes information about the project team (Project Team Members and their roles in the project). Project Team Members who do not have access to the application are listed in the Comments box near the bottom of the page.
- Application Custom Questions Tab: This tab will be named after the application you are reviewing. It contains questions that are specific to the type of application. There are various sub-tabs beneath this tab. Be careful while navigating the sub-tabs so you do not miss any information.

Application Tabs Cont'd



 Attachments Tab: Allows you to view attachments added to the application by the Researcher, Research Team, or ethics office. If the ethics office has highlighted specific files for your attention, they will appear at the top of the attachments list and will be in red text.

- Approvals Tab: Illustrates the electronic workflow of the application.
- Log Tab: Allows you to view the history of the application. This includes the workflow and the edit history.



To see all the reviewer's comments, please proceed to the **Committee Reviews Tab** in the Memorial Researcher Portal. The Reviewer Table includes the following information:

- **Reviewer:** The various members of the review committee who are assigned to this file. The Chair will be highlighted in red as seen below.
- **Comments:** The individual comments made by each reviewer.
- **Date Reviewed:** The date that the reviewer has completed their review and submitted their final comments.

There are two ways to record reviewer comments:

1) You may open a blank Word document or Notepad on your screen while you review the application online and record any comments in Word or Notepad. As you enter your comments, be sure to prefix them with the question number. This allows other reviewers to easily follow your comments. Once you have compiled your comments in Word or Notepad, you can then copy and paste them into the **Comments Window** which appears when you click the **Review** button as seen in the screenshots below.

Once you have entered your review comments in the "Comments" window, you have three options.

- iii. Close the Comments window without saving your comments, by clicking the **Close** button.

2. You can also review an application by exporting it to Word. Click the **Export to Word** action button as seen in the screenshot below. Please note that when exporting to Word, only the application questions and answers are exported. Any supporting documents found on the "Attachments" tab need to be downloaded from that tab individually.

You can then choose to print the application and review it. As you review it, you can compile your comments in a separate Word document. We recommend that you prefix your comments with the question number that you are commenting upon. This allows other reviewers to easily follow your comments.

Once you have compiled your comments in Word, you can then copy and paste them into the **Comments Window** which appears when you click the **Review** button as seen in the screenshots below. **Be sure to delete the Word document on your computer once you are finished with your review.**


Once you have entered your review comments in the "Comments" window, you have three options.

When you are preparing to submit your review you must select a review decision. <u>Please ensure all reviewers have completed their review prior to</u> <u>submitting a review decision.</u> If you submit a review decision prematurely, please contact your Human Ethics Administrator to unlock the decision.

- An event form is an additional submission made by the PI or Project team once an application has obtained ethics approval. Event forms include items such as amendments, renewals and study closures.
- Completing a review of an event form is similar to a review of an application. You will receive an email when you are assigned as a reviewer for an event form. You will follow the same procedure to login to the Memorial Researcher Portal. To access the event form, you will click the appropriate event link on the Memorial Researcher Portal Home page.
